**H and I Chair Report
YEAR END 2020**

The H&I Committee has had as successful a year as possible in 2020, despite the ever changing situation that the year has brought and the unbelievable circumstances we all find ourselves in. The committee carried out our fifth tradition and this committee's primary purpose as best we could, to carry the message to the addict who stills suffers.

As chair, I proposed cancelling the October H&I Learning Day this year because I felt that support for the event would be because it had to be held virtually and, as it was my responsibility as chair to organize the event pursuant to the guidelines, I didn't think it would be successful. I consulted with members from another committee on this decision and received some similar feedback. The committee was split on the decision but ultimately voted to cancel the event.

H&I has ten panel members in place and all panel positions are currently filled. Officers have been voted into all positions for the upcoming year and the committee is ready to move forward.

Reviewing the year from a budget perspective, H&I submitted a 2020 budget for literature in the amount of \$2700 or \$225 per month. I estimate that the committee used \$450 of this literature budget plus \$89.94 in zoom fees for a total expenditure of \$539.94. The literature estimate is based on the fact the presentations were held in person in January and February of this year. The remainder of zoom costs were donated by H&I members as was reported throughout the year.

The 2021 budget will be discussed at the upcoming business meeting and will include costs necessary to operate virtually for as long as necessary, with both the presentations and the monthly business meeting (they are separate), and an estimate of literature needs.

As the year wraps up, I am grateful to all of you. I have learned so much as chair this year. I have confidence in the 2021 H&I officers, panel members and committee going forward and look forward to remaining a part of the important work it does for addicts in the Rochester area. Thank you.
